MATTERS ARISING.

- 1. The Clerk confirmed that following the last meeting he had checked with other providers that the Insurance premium from Came & Company represented value for money and a cheque was signed by three councillors for the three-year deal. This retrospective action was APPROVED.
- 2. SITA had advised that the commencement of the restoration programme would now start in January. The contract had been let.
- 3. A further half-load of road planings would be coming in mid January to complete the works needed on Byway 24 behind the Playing Field.

- 1. The Minutes of Carharrack Parish Council's meeting of 17th November 2014 were noted.
- 2. The Litter Clearing report for December was received and the additional reporting of fly-tipping noted.
- 3. Cornwall Council had sent a letter informing that a new Parking Order for Cornwall is being prepared.
- 4. A comparison of Fly Tipping incidents for the three months September December 2014 and 2013 showed a huge increase since the HWRC began charging for certain types of waste.

- 3. An incident with the water tap in the disabled toilet had been repaired by Ann Gazzard & Robin. This was appreciated by the Council.
- 4. Cormac had delivered the dumpy bag of salt/grit to the Playing Field for the public to use on public places.
- 5. Cllr Humble had contacted the play equipment inspector regarding the small central gate to the children's area. In strong winds the spring was not closing the gate properly, but it was thought that this may no longer be a requirement.
- 6. Robert Cook had tidied the Crofthandy Bus Shelter, washing down and removing graffiti.

FOOTPATHS/ENVIRONMENTAL

- 1. The tender for grass and footpath maintenance had appeared in the West Briton last month and several information packs had been sent out to prospective contractors.
- 2. All Councillors were satisfied that the positioning of the litter bin at Lower Cusgarne was in a reasonable position and should not be removed because of the complaint of resident.
- 3. The parts of Coombe Lane that remained untrimmed are with Cornwall Council's Safety Inspector who will be taking action against the landowners.
- 4. The Clerk will request additional infill for the cycle trail at the Twelveheads Poldice section where the potholing is particularly bad.
