MINUTES OF THE MEETING OF GWENNAP PARISH COUNCIL HELD AT THE PARISH ROOMS, PULLA CROSS ON 20th JUNE 2019 at 7.00pm

• Mr Datson spoke in support of his application PA19/03911, explaining the reasons for the development.

19/044 APOLOGIES Apologies were received and accepted from Cllrs Patton and Hallett.

19/045 DECLARATION OF INTERESTS No interests were declared for this meeting.

19/046 CORNWALL COUNCILLOR KACZMAREK'S REPORT

- Cllr Kaczmarek met with a Camborne Police Inspector who is covering the Gwennap parish area, including Wheal Jewel. They discussed Wheal Jewel and fly tipping (in particular abandoned caravans). They agreed that CC need to work more closely with the Police, Environment Agency and Environmental Protection team to combat the problems. Adam Fitzpatrick (Cornwall Housing) also attended the meeting.
- Wheal Jewel an unauthorised family on site have been causing problems. Cornwall Cllr Kaczmarek continues to press CC and Cornwall Housing to install a horseshoe barrier at the entrance, to prohibit caravans entering and leaving without permission.
- There have been two recent road traffic accidents in the area, one on the Comford to Lanner road, and another on the St Day to Carharrack road.
- He has attended meetings with Cornwall Council and businesses regarding possible uses of the heat generated by the United Downs Deep Geothermal Power site. These discussions are confidential at this stage.

All Clirs present agreed that they could see no valid reason why the public comments should have been removed from the public portal. 19/051 REPORTS ON EXTERNAL MEETINGS ATTENDED

- 051.1 Cllrs Patton, Leach, Hallett & Pascoe attended an Environmental Growth Workshop run by CC on 12th June. Cllr Patton spoke on behalf of the Parish Council, about the measures it is taking to reduce its carbon footprint, eliminate the use of pesticides in the work it carries out and to invest in planting within the parish. The talk was very well received and thanks were received for the Cllrs attendance and the excellent talk. An 'Alternatives to Pesticides' event is being held on 11th July, and Gwennap PC have again been invited to talk. Cllrs to contact the Clerk if happy and available to attend.
- 051.2 Cllr Leach attended three fete committee meetings, and the first Repair Workshop on 7th June which was very successful. He has discussed the Gwennap Church bat project with Mrs V Stone, more information to follow.
- 051.3 Cllr Pascoe attended an interesting 'Rewilding UK' meeting. Cllr Pascoe to investigate 'Growth Seed Money'.
- 051.4 The Clerk provided the Cllrs with a summary of meetings she attended re. antisocial behaviour and fly tipping (with members of MVRG and CC's Environment Protection team); the Gypsy & Travellers Forum that highlighted the multi-agency approach to tackle antisocial behaviour on site at Wheal Jewel, and the greater focus being placed on making improvements, demonstrated by the employment of three new roles within CC/Cornwall Housing specifically working on G&T matters; and Teyluva's Open Day that was well attended my multi agencies.

19/052 WORKING GROUPS/PROJECT UPDATE REPORTS

- 052.1 <u>United Downs Deep Geothermal Power Project</u> drilling of UD-2 is progressing well and GEL anticipate completion by the end of June.
- 052.2 <u>Neighbourhood Development Plan</u> –the independent planning inspector will commence their review of the NDP in the last week of June.

- 052.3 <u>CLT Housing Working Group</u> investigations are progressing at a potentially suitable site within the parish. If those investigations look promising, then public consultation will be arranged.
- 052.4 <u>Community Transport Scheme</u> the Clerk will contact those that have expressed an interest in becoming a volunteer driver, to reconfirm and arrange training.
- 052.5 <u>Sustainability Working Group</u> no further update. An Extra-Ordinary meeting is due to be held on 27th June to discuss the redrafted Sustainability Policy and Climate Call to Action.

19/053 PUBLIC RIGHTS OF WAY(PROW) / OPEN SPACES / ENVIRONMENT

- 053.1 The monthly Wheal Maid inspection report was noted.
- 053.2 An invitation to attend a meeting re a community wood in Kea parish was noted.
- 053.3 The Council APPROVED a revised quote dated 17/06/19 from Mr Ely for the Cornish wall at Wheal Maid.
- 053.4 Campaign to Protect Rural England & Tree Warden update (Cllr Hallett) none.
- 053.5 Land use / acquisition Cllrs to consider suitable sites for a tree planting scheme.
- 053.6 'Green Gwennap' Cllrs discussed a potential tree planting scheme, and if 10,000 trees by 2030 is achievable? Public or private land? Cllr Furnish reminded Cllrs that woodland has been planted on the restored landfill site at United Downs and there is extensive woodland above Wheal Maid valley and behind Wheal Clifford. Cllrs discussed if a target of planting one tree for every parishioner before the end of 2019 is achievable? The Woodland Trust can provide free trees for public spaces. Cllr Forrest to investigate, inc. Grow Nature Funding.
- 053.7 Cllrs AGREED to donate £40 to the charity of retired litter picker Mr Cook's choice, as thanks for his service.

19/054 HIGHWAYS

054.1 The Clerk reported that the Mobile Speed Activated Sign (MSAS) has been received. There is a min. 8 week wait for Cormac to install posts at the approved locations, before the MSAS can be installed and used.

19/055 GWENNAP CHURCHYARD / FROGPOOL CEMETERY

- 055.1 Gwennap Churchyard Policy, drafted by Cllr Leach Cllr Furnish to read and email comments to Cllr Leach.
- 055.2 CC have advised that extensive tree work is required at Gwennap Churchyard, they have asked if Gwennap PC will share the cost. Cllrs to review the Tree Report before the Parish Council responds to CC.
- 055.3 Following receipt of further complaints about dogs and dogs mess in the Cemetery, the Council AGREED to erect more explicit signage at Frogpool Cemetery prohibiting dogs from the Cemetery. Clerk to action.

19/056 PARISH ROOMS AND PLAYING FIELD

- 056.1 The monthly play park inspection was noted. Clerk to action one minor matter.
- 056.2 Cllrs discussed whether it should erect surveillance cameras at the playing field and playpark, following recent obscene graffiti in the gazebo. Clerk to investigate and report back. The Council instructed the Clerk to put up some signs about surveillance at the park, and to request visits by the Multi Agency Officers.
- 056.3 Cllr Leach has arranged a 6-week IT course for over 60's starting 9th August. There will be morning and afternoon sessions, 10 places in each. The course is free, but donations are welcomed, to contribute towards the cost of room hire and refreshments. Parishioners to contact Cllr Leach to book/for more info.
