





Minutes of the Ordinary Parish Council Meeting held on Tuesday 10th October 2023, 7pm

<u>In attendance:</u> Cllr Richard Williams {Chair} (RW), Cllr Greg Foxwell {Vice Chair} (GF), Cllr Steve Trelease (ST), Cllr Lynn Begley {LB}, Chris Ring {Parish Clerk} (PC).

Members of the public were in attendance

- **1. Apologies for absence** were received from Cllr Andi Freeman{AF}, Cllr Veryan Pascoe-Edward {VPE},Cornwall Councillor John Thomas
- **2. Declarations of interest**: Cllr Steve Trelease (ST) re item 4. Cllr Lynn Begley {LB} re Planning application PA23/07592

3. Public Session:

- **3.1** Mr Ben Wood, planning consultant, and the applicant for Pre-Application PA23/00458 spoke briefly to inform the Council of this pre application.
- 3.2 The applicant for Planning Application PA23/06890 spoke to give details of this revised application.
- **3.3** A Planning agent for Planning Application PA23/06523 gave a detailed explanation of this application and answered questions from the Councillors and members of the public.
- **3.4** Numerous members of the public attended the meeting, and a substantial portion of them took the floor to express their apprehensions pertaining to Planning Application PA23/06523. The concerns raised encompassed a spectrum of issues, most notably: access difficulties, drainage and flooding concerns, the potential for increased traffic, and the perceived excessive size of the proposed development.
- **4.** To hear from prospective candidates for co-option to the Parish Council.
- Two candidates were present at the meeting, both expressing a keen interest in being co-opted onto the Parish Council. They provided concise accounts of their motivations for seeking this appointment and also answered questions posed by the Councillors.
- **5.** A report from Cornwall Councillor John Thomas MBE was forwarded to the Parish Clerk, and subsequently, it has been circulated to the Councillors. This report, along with the minutes, will be made available to the public on the parish website.
- **6.** It was PROPOSED by (RW), SECONDED by (GF) and RESOLVED that the minutes of the Parish Council meeting of 30th August 2023 be approved as a correct record. (RW) signed the approved minutes of that meeting.

7. Matters arising from the minutes

- **7.1** Banger racing at United Downs. {RW} had sent a letter to the Commercial Estate Manager at Cornwall Council, inquiring about the specifics of the proposed new lease for the banger racing track. Subsequently, the Clerk engaged in a conversation with the Commercial Estate Manager, who confirmed that the lease has not yet been finalised. He expressed his intent to gather more information, which would include consultations with the Parish Council.
- **7.2** A new seating bench has been successfully installed in the vicinity of the Methodist Church and the Parish Cemetery. It was noted that this bench has been crafted from recycled plastics collected from Cornwall and Devon, underlining the Parish Councils commitment to sustainability.

8. Correspondence:

- **8.1** A request for a Bus shelter in Gwennap had been received. In response, the Clerk explored the possibilities for fulfilling this request, engaging in consultations with Transport for Cornwall and Cornwall Council. Additionally, the Clerk has brought this matter to the attention of Councillor John Thomas, who has graciously agreed to conduct further investigations into this issue.
- **8.2** An email had been received regarding the illegal use of trials motorcycles in the Parish. RW had replied stating that this had been discussed at meeting he had attended and that he would raise the issue again.
- **8.3** Training in the use of scythes was available, details of this would be shared with all the Councillors and members of the environment group.
- **8.4** A request had been received from the Countryside Officer (Public Rights of Way) regarding PROW-13. Following a visit to the site by RW and GF, it has been proposed that the Clerk initiates communication with the homeowner adjacent to the path to engage in further discussions on this matter.
- **8.5** The Clerk had previously submitted a report to Cornwall Council regarding an alleged removal of a Cornish hedge to establish access and a track near Bissoe Hill. We have recently received a response from Cornwall Council confirming their initiation of an investigation into this matter.
- **8.6** Information regarding the Chacewater Energy Debate on Sat 14th Oct ad been received. This had been shared with the Councillors and posted on Social Media outlets.
- 8.7 The Clerk had replied to an enquiry regarding weed killer use within the Parish.

9. Youth Club.

9.1 The Clerk had received confirmation that our additional funding requests have regrettably been declined.

{LB} provided a report indicating a notable decline in recent Youth Club attendance.

Previously, the Council had passed a resolution that in the event of unsuccessful funding acquisition, the Youth Club would be compelled to cease its operations.

In accordance with this, it was PROPOSED by (RW), SECONDED by (GF) and RESOLVED that the Parish Council would cease its funding of the Youth Club after the 30th of October. The Clerk will notify the Youth Work providers, and a letter will be prepared for {LB} to distribute among the young participants.

- 9.2 {LB} also shared her report about attending the inaugural session of the new Youth Football teams, Dropship Youth FC. It was confirmed that the session was well-organised and well-attended.
- 9.3 It was PROPOSED by (RW), SECONDED by (GF) and RESOLVED that Clir Lynn Begley be formally extended a vote of thanks for her dedicated work with the Youth Club.

10 Highways and Public rights of way.

- 10.1 Village Gateways: The Clerk submitted an expression of interest application to Cornwall Council for the installation of Village Gateways within the Parish. The Clerk extended gratitude to Lucy Richards, whose significant contributions were pivotal in the submission of this application. It was acknowledged that Cornwall Councillor John Thomas has also affirmed his support for this application.
- 10.2 A Virtual Footbridge at Bissoe had been suggested by Lucy Richards (Traffic Group). The Clerk had submitted an expression of interest application to Cornwall Council but this was now on hold while Kia Parish conducted their traffic consultations. The application would be re-submitted at a future date.
- 10.3 An enquiry had been received from St Day Parish regarding the installation of streetlights in Crofthandy. The Clerk initiated a preliminary discussion with a St Day Councillor. However, further investigations and discussions are required before any formal proposal can advance. The Clerk is currently in the process of scheduling a meeting with representatives from St Day to explore this matter in greater detail.

11. Parish rooms and Playing Field.

- 11.1 After a discussion regarding the prohibition of Dogs on the Richard Jory Playing Field, it was PROPOSED by (RW), SECONDED by (GF) and RESOLVED that the existing prohibition of Dogs on the field be continued.
- 11.2 RW, GF and the PC had attended a meeting with Marraum, the architect for the proposed Parish Rooms project. RW confirmed that further public consultations would begin soon.
- 11.3 The Clerk has received a single quote for the exterior cleaning of the Parish Rooms. To ensure a comprehensive assessment, further quotes will be sought, and a detailed report will be presented at the upcoming meeting in November.

12. FINANCE:

- 12.1 It was PROPOSED by (RW), SECONDED by (GF) and RESOLVED that the expenditure, as shown below, be approved for payment.
- 12.2 It was confirmed that no Councillor have any conflict-of-interest with the External Auditor BDO LLP.
- 12.3 It was PROPOSED by (RW), SECONDED by (GF) and RESOLVED to accept the External Audit as reviewed.
- 12.4 The Clerk gave a short report on the finances and the Budget for 2024/25, a full budget and level of precept suggestion will be sent to the Councillors to be approved at the following meeting.

(POLICY H2 - Housing developments within the development boundary of Gwennap parish villages, as delineated on maps at Appendix 4, will be permitted where they are Small-Scale {of one or two dwellings})

15. Reports from Councillors in relation to meetings attended on behalf of the Parish Council:

- **15.1** {LB} discussed that the village fate had only reported a small profit. {LB} will attend future meetings of the Fete Committee to discuss this further.
- **15.2** {LB} confirmed that she had assisted in arranging a visit to the Cusgarne School from Luci Isaacson, Shaping Climate Vision CIC
- **16.** The Council is invited to pass the following resolution "That under the Public Bodies (Admission to Meetings) Act 1960 it is advisable in the public interest that the press and public be temporarily excluded, and they be instructed to withdraw in view of the confidential nature of the business on contracts and leases about to be transacted'.

17. To discuss any candidates for co-option as item 4, to resolve if a candidate will be co-opted if approved.

- **17.1** After conducting interviews with two candidates, it was resolved that Mr. Julian Hughes be co-opted to the Council. It was noted that both candidates were highly qualified and eminently appointable for the position, and there is hope that the unsuccessful candidate will continue to actively engage with the Parish Council and the community. It is encouraged that they consider applying again in the event of another vacancy.
- **17.2** As per correspondence from Cornwall Council, the contract for the arrangements for Street Cleansing were discussed.

RW and the Clerk will maintain an ongoing correspondence with Cornwall Council to secure the seamless continuation of effective Street Cleansing arrangements within our Parish.
